# Transport Canada on Wrong Course for Flight Training Schools

Transport Canada has been consulting with industry on the appropriateness of expanding the cap of 25% foreign ownership of Canadian FTUs. ATAC opposes this proposal to increase foreign ownership as it is not in the best interest of the Canadian public. In fact, allowing increased foreign ownership could limit the number of Canadian students at FTUs which is counterproductive to dealing with pilot shortages in Canada. ATAC implores the Federal Government to focus on real issues facing Canadian Flight Training, such as funding of Canadian students and recovery support of the industry from the pandemic.



### **ATAC Participates in National Supply Chain Summit**

ATAC Chair Chris Avery, President and CEO of Canadian North, participated earlier this week on the National Supply Chain Summit chaired by Minister Alghabra. Chris spoke to the following key elements of the supply chain:

- The need to help fund flight and aircraft maintenance training to overcome labour shortages.
- Support critical infrastructure such as NAV CANADA in times of crisis to reduce the financial and operational impact to supply chain providers.
- 3. Invest in regional and remote airport infrastructure such as improved approach lighting at remote airports which will lead to lower approach minimums.
- Improved airport infrastructure investments which will help airlines to deliver essential services more reliably.
- Better coordination of the various future health/Covid directives around close contact, isolation periods and ability to return to work between Provinces, Territories, Municipalities and the Federal Government.
