



ArriveCAN – Vaccinated Travellers July 5

Key Messages

- Canadians are advised to avoid non-essential travel outside of Canada until further notice. Staying in Canada will help to protect yourself, your family and those most at risk of severe illness from COVID-19 in our communities.
- Vaccination rates and continued strong public health measures matter. Together they are lowering case counts and reducing hospitalizations. These successes are setting the stage for a cautious and calibrated adjustment to border measures for travellers entering Canada.
- The first phase of the Government of Canada’s approach towards easing border measures will allow some exemptions for fully vaccinated travellers who are currently eligible to enter Canada.
- Beginning July 5, 2021 at 12:01 a.m. ET, fully vaccinated travellers who qualify for an exemption will not be required to quarantine or complete a day-8 test. In addition, fully vaccinated travellers arriving by air will not be required to stay at a government-authorized hotel to await their on-arrival test result.

Requirements for fully vaccinated travellers entering by land or air

- To be considered fully vaccinated, travellers must have received the full series of a COVID-19 vaccine — or combination of vaccines — accepted by the Government of Canada, at least 14 days prior to entering Canada. Currently, those vaccines are manufactured by Pfizer, Moderna, AstraZeneca/COVISHIELD, and Janssen (Johnson & Johnson). Travellers can receive their vaccine in any country.
- To be eligible for these exemptions, fully vaccinated travellers must still meet the pre-entry and on-arrival testing requirements, be asymptomatic, submit all required COVID-19 information electronically into ArriveCAN prior to travel to Canada, have a paper or digital copy of their proof of vaccination, and have a suitable quarantine plan.
- Travellers must enter their vaccination status and upload supporting English or French documentation (or a certified translation), into the ArriveCAN app or by signing-in online at [Canada.ca/ArriveCAN](#) before arriving to Canada.
- All travellers entering Canada must submit their information into ArriveCAN within 72 hours before arrival to Canada, including:



- pre-arrival COVID-19 negative molecular test result taken within 72 hours of arrival/departure time or proof of positive molecular test result within 14-90 days before arrival
 - travel and contact information
 - 14-day travel history
 - proof of vaccination
 - quarantine plan (unless otherwise exempt)
 - COVID-19 symptom self-assessment
 - reference code for a confirmed three-night reservation at a government-authorized accommodation (for air travellers only, unless fully vaccinated or exempt)
- Travellers using the ArriveCAN app need to make sure they have the most up-to-date version that will be released on July 5 at 12:01 am ET in the Google Play Store and the App Store for iPhone.
 - The new version of ArriveCAN will be released on July 5, 2021 at 12:01 AM ET. You will not be able to upload your proof of vaccination into ArriveCAN **until that time**.
 - Travellers may receive notifications or emails from ArriveCAN after arrival; however, you are not required to complete reporting if you receive the fully vaccinated exemption.
 - Travellers who submitted their information in ArriveCAN prior to the ArriveCAN update scheduled for July 5 at 12:01am ET will need to update the app or sign in online after this time and resubmit their information before arriving at the border, including vaccination status and proof of vaccination.
 - Travellers must retain a copy (paper or electronic) of their vaccination documentation and the originals of any certified translations for verification at the border and for 14 days following their entry to Canada.

Requirements for travellers entering Canada by marine:

- ArriveCAN isn't mandatory if you're travelling to Canada by marine.
- However, travellers are strongly encouraged to submit their travel information through ArriveCAN to speed up processing at the border and limit points of contact.

ArriveCAN Receipt:

- Travellers must be ready to show their ArriveCAN receipt when seeking entry into Canada; a border services officer will verify that they have submitted their information electronically. Travellers can show their ArriveCAN receipt as a screenshot, printout or email.
- Travellers must retain a copy (paper or electronic) of their vaccination documentation and the originals of any certified translations for verification at the border and for 14 days following



their entry to Canada.

- Travellers who do not submit the required information electronically through ArriveCAN before boarding their flight or before arrival at a land border crossing could be subject to enforcement action, which can range from verbal warnings to a \$5,000 fine.
- Travellers who are in transit to another country (and aren't leaving the secure area at the airport) shouldn't submit their information through ArriveCAN.

Using ArriveCAN for someone else:

- ArriveCAN also supports multi-traveller submissions. A primary traveller can submit information on behalf of up to another 7 persons travelling with them, as long as all travellers are staying at the same location for the entire 14-day quarantine or isolation period upon entry in Canada. Upon entry to Canada, the primary traveller will show the one ArriveCAN receipt to the Canada border services officer for all of the travellers. This feature is available for:
 - spouses or common-law partners
 - dependent children
 - any other adult for whom the primary traveller is a legal guardian.
- Travellers can also have another person submit their information by signing in online, even if that person is not travelling with them to Canada. The person would provide a copy of the ArriveCAN receipt to the traveller by printing it or sending them a screenshot. The traveller would then show the receipt to the Canada border services officer at the port of entry.

ArriveCAN Social Media Messages

Eligible travellers to Canada must submit their #Covid19 info electronically through #ArriveCAN within 72 hours before arrival. An updated version of ArriveCAN will be released on July 5. Make sure you have the latest version!

Travellers to Canada must submit the following in ArriveCAN:

- travel and contact info;
- travel history
- quarantine plan
- vaccination info
- confirmation of a 3-night stay at a government-authorized hotel (if applicable); and
- #COVID19 self-assessment.

Fully vaccinated travellers to Canada who do not submit their #COVID19 info in ArriveCAN will not benefit from exemptions from certain public health measures. A traveller can also have a friend or family member enter the information into ArriveCAN for them.
